Services:

Kennel agrees to provide a clean, secure environment for Dog(s) with multiple potty breaks daily. Dog(s) shall have access to fenced yard for daily play and exercise. Dog(s) may also be leash-walked on premises. Dog(s) enrolled in Brush-Up Training shall have a minimum of one individual training session per day. If Client wishes, Dog(s) may play with other canine clients deemed suitable by Kennel.

Requirements:

Dogs in heat or that are ill will not be allowed to stay at Kennel. Dogs must have all required vaccinations or proof of protective titers for the following: DHPP (Distemper, Hepatitis, Parainfluenza, and Parvovirus) and Bordetella (Kennel Cough). A copy of proof of vaccines or titers must be presented at start of session. Dogs must also be on a heartworm preventative and a flea and tick preventative and the Client must provide these medications for the Dog if required during the course of the session. All dogs will be inspected for fleas at time of intake and if found will be given a dose of Capstar at Client's expense. Kennel may refuse to accept (or may terminate this Agreement and require Client to immediately pick up) any Dog(s) whose health, condition or behavior could jeopardize the health or safety of Master's Voice Canine Training, LLC personnel or other animals.

Client understands that other dogs will attend Master's Voice Canine Training, LLC's programs and during the course of participation Dog(s) may come into direct contact with other participating dogs. Dog(s) will also be exposed to a variety of surfaces and weather conditions. Client understands and that an interactive play setting is not without some risk of injury, that despite all dogs appearing healthy and being handled with the greatest amount of care, dogs are not always predictable and the unexpected may occur.

Client agrees to release photos and videos of Dog(s)'s likeness obtained during course of boarding for use in promotional materials by Kennel.

If Dog(s) becomes sick or injured during the course of stay, Client agrees to grant Kennel the authority to engage the services of a veterinarian of Kennel's choice. In non-emergent situations every effort will be made to contact Client prior to any treatment. Charges by Kennel or any veterinarian for services performed shall be paid by Client.

Abandonment Policy:

Dog shall be deemed abandoned if Client fails to pick up Dog(s) on the day for pick up indicated above, or if Client fails to pay applicable charges. If Client does not pick up Dog(s) and all charges settled within 7 days from the date Kennel mails to Client (at address indicated above) written notice that Dog(s) is/are considered abandoned, Kennel may either sell Dog(s) to recover incurred costs, or deliver Dog(s) to a humane society, rescue organization or other person as an abandoned pet and Trainer shall have no further responsibility for Client's Dog(s). Client will continue to accrue and be liable for unpaid charges, including boarding charges until Dog(s) is/are sold or delivered as an abandoned pet.

Liability:

If Dog(s) causes property damage, or bites or injures any dog, animal or person (including but not limited to Kennel and Kennel's agents), during or after the term of this Agreement, then Client agrees to pay all resulting losses and damages suffered or incurred, and to defend and indemnify Kennel and Kennel's agents from any resulting claims, demands, lawsuits, losses, costs or expenses, including attorney fees. If Dog(s) is/are injured in a fight or in any other manner during or after the term of the Agreement, Client assumes the risk and agrees that Kennel should not be held responsible for any resulting injuries, losses, damages, costs or expenses.

At Kennel's sole election, Kennel's duties hereunder shall terminate if (a) in Kennel's sole judgment Dog(s) is/are dangerous or vicious to Kennel or any other person or animal, or interferes with the training of other dogs, or (b) Client breaches any term or condition of this Agreement. Upon termination in accordance with the foregoing, Trainer's duties shall terminate but all other provisions of this Agreement shall continue in full force and effect.

This Agreement is binding upon Client, and spouse of Client. This Agreement supersedes all prior discussions, representations, warranties and agreements of the parties, and expresses the entire agreement between Client and Kennel regarding the matters described above. This Agreement may be amended only by a written instrument signed by both Client and Kennel.
